Notes

1. All fees for all appointments to SHPCL fixtures are inclusive of travelling expenses.
2. Herts County AWAY matches pay expenses for travel over 50 miles (round trip) at the rate of 45p/mile - to be claimed from the Treasurer.
3. Herts County and Schools multi-day matches pay the quoted fees per day.
4. Umpires standing on their own in SHPCL (Div 2A/2B) or County Age Group matches will receive an uplift of 50% to the relevant match fee, plus £5 for tea where applicable.
5. Transport will normally be provided for O50/60/70 AWAY matches. However on rare occasions, when a long distance is involved to a play-off match, the players might decide to stay overnight.
In such a situation if the travelling umpire and scorer wish to return on the day of the match, they are entitled to claim the cost of fuel for one car between them. Contact John Sweedy for details of how to claim.
